A BRIEF HISTORY OF VITAE NATURALS

2018 Last 28 February, Vitae Naturals successfully achieved REACH registration of tocopherols ("Vitapherole" range – mixed tocopherols and dalpha tocopherol) and Registration Number for both substances were issued. This registration enables Vitae Naturals to market its products in the context of cosmetic sector within established legal regulations.

2016 Vitae Naturals is successfully audited under FSSC 22000 standard. This new certification controls and reduces Food Safety Hazards and promotes continuous improvement in Food Safety aspects. Vitae Naturals, through this certification, bets for transparency along the Food Supply Chain. FSSC 22000 is fully recognized by the "Global Food Safety Initiative (GFSI).

2015 Installation of a state of the art micro-encapsulation facility in Talavera de la Reina. We will offer microencapsulated tocopherols and sterols produced entirely by Vitae as well as contract manufacturing services of vitamins, minerals and omega 3.

2014 Our Vitasterol® range has achieved "self-affirmed GRAS" status in USA. US FDA carried out an exhaustive inspection at our facilities last April.

2013 Vitae Naturals invests in research and innovation starting a new CDTI project related to new formulations of phytosterols for food and nutraceutical sector. Launched Vitasterol S-80 WDP.

2011 Vitae Caps is commercially renamed Vitae Naturals, to better reflect its vision and commitment to the purest natural ingredients.

2009 Plant sterols were one of the first products to gain Health Claim approval under regulation art. 14 of European Regulation 1924/2006. We are working on two CDTI (Council of Administration of the Center for Industrial Technology Development) projects until the end 2011, one of them is the study of natural tocopherols as new source of vitamin E in feed sector.

2008 Vitae Caps began developing tailor-made antioxidant systems and microencapsulated products. Launched Vitaslim® (CLA).

2006 Launched Vitasterol® S-80 esterified, with the highest purity available in the market >99% esterification, which is one of our best sellers today. Vitasterol® S-80 esterified obtained novel food ingredient approval following a simplified procedure of substantial equivalence according to European Regulation 258/97.

2003 Vitae Caps has been pioneer in the implementation of the non GMO IP Certification Program based on the strictest criteria from European Regulation 1829/2003 and 1830/2003.

2001 Vitae Caps opened their facilities as the leading producer of natural sourced Vitamin E in Europe.
